Action: ERCOT provided an update on CPS' Braunig 3 unit. A crack found in the unit's superheater may extend the duration of the outage until Spring 2026. This finding led to an increase in cost of approximately \$3-4 million, but this is within the range of anticipated discovery costs. Even with the delay, ERCOT believes it is still beneficial to move forward with the Braunig 3 unit. Additionally, an agreement was reached between ERCOT and LifeCycle Power for the mobile generation units, with a goal of having these units online this summer. CPS Energy and CenterPoint are close to finalizing their agreement to move the units.
