Chairman Gleeson called the meeting to order.

A quorum was established with all commissioners in attendance.

Chairman Gleeson was recused from Item No. 14.

Items Not Taken Up

Public Comment

Another commenter stated that wind and solar should be charged a \$1 per megawatt (MW) fee to fund storage that their production is going to require. Another commenter reminded the Commission of its Compact with Texans and its duty to protect consumers. Another commenter asked if the Commission had received the report he had sent them and asked if the Commissioners felt they were living up to the Compact with Texans. Three commenters spoke about grinder pump failures in their subdivision and Undine's failure to repair the pumps. One of these commenters urged the Commission to revoke Undine's authority to operate as a result of sewer discharge into Lake

Austin. Two commenters representing a small, public water system explained that their corporate structure does not allow them to sell water outside of their subdivision and they do not need a CCN to operate within their subdivision.
