
PROJECT NO. 50019 PUBLIC UTILITY COMMISSION OF TEXAS PUBLIC NOTICE OF 2019 SUMMARY OF CUSTOMER COMPLAINTS AND ENFORCEMENT ACTIVITIES AND REQUEST FOR COMMENTS

As a part of its 2010 report on the PUC, the Sunset Advisory Commission adopted a management action recommending that the Commission publish, on a regular basis, more complaint and enforcement data on its website. The Sunset Commission also recommended that the public be given an opportunity to comment on this information. 

Fiscal Year 2019 Complaints Received





Electric Complaint Categories - FY 2019





Telecommunications Complaint Categories – FY 2019





Water Complaint Categories - FY 2019



Complaints Received Comparison – FY 2018 and FY 2019





Average Refund* - FY 2019





Total Investigations Opened Within Fiscal Year 2019





Total Investigations Closed Within Fiscal Year 2019





Docketed Cases that Resulted in Administrative Penalties: Percentage of Total Penalties Assessed by Violation Type Fiscal Year 2019




