NOTICE OF APPROVAL SETTING CPI-ADJUSTED CITY-PREFERRED ACCESS LINE RATES FOR YEAR 2023

This Notice of Approval addresses city-preferred access line rates for the year 2023. Under 16 Texas Administrative Code § 26.467(j) and Texas Local Government Code § 283.055(g), the Commission annually revises the access line rates for Texas municipalities by an amount equal to one-half the annual change in the most recent consumer price index (CPI). For the year 2023, this amount results in an increase of 4.2883%.

On February 16, 2023, the Commission approved a 4.2883% increase in maximum access line rates for Texas municipalities with Commission-approved rates.¹ However, because several municipalities adopt less than the maximum allowed, the Commission also ordered that:

- A municipality whose 2022 city-preferred access line rates are below its 2023 CPI-adjusted maximum access line rates will remain at its 2022 city-preferred rates unless it notifies the Commission of its desired rates no later than April 30, 2023.²
- For a municipality whose 2022 city-preferred access line rates are equal to its 2022 CPI-adjusted maximum access line rates, the new 2023 city-preferred access line rate will be set equal to the new 2023 CPI-adjusted maximum access line rates unless the municipality notifies the Commission of its desired rates no later than April 30, 2023.³

No municipality responded to the Commission’s February 16, 2023 Order either to affirm the Commission’s default rates or to decline the default rates and choose different rates.

On October 23, 2001, the Commission issued an order delegating authority to Commission Staff to administratively approve revisions to access line rates.⁴ This Notice of Approval is issued in accordance with that authority.

Ordering Provision

Attachment A to this Notice of Approval contains the year 2023 city-preferred access line rates incorporating any adjustments requested by the municipalities. These rates are approved and must be implemented prospectively no later than July 1, 2023.
