**NOTICE OF APPROVAL SETTING CPI-ADJUSTED CITY-PREFERRED  
ACCESS LINE RATES FOR YEAR 2024**

This Notice of Approval addresses city-preferred access line rates for the year 2024. Under 16 Texas Administrative Code § 26.467(j) and Texas Local Government Code § 283.055(g), the Commission annually revises the access line rates for Texas municipalities by an amount equal to one-half the annual change in the most recent consumer price index (CPI). For the year 2024, this amount results in an increase of 2.2484%.

On February 15, 2024, the Commission, in the present docket, approved a 2.2484% increase in maximum access line rates for Texas municipalities with Commission-approved rates.<sup>1</sup> However, because several municipalities adopt rates less than the maximum allowed, the Commission also ordered that:

- A municipality whose 2023 city-preferred access line rates are below its 2023 CPI-adjusted maximum access line rates will remain at its 2023 city-preferred rates unless it notifies the Commission of its desired rates no later than April 30, 2024.<sup>2</sup>
- For a municipality whose 2023 city-preferred access line rates are equal to its 2023 CPI-adjusted maximum access line rates, the new 2024 city-preferred access line rate will be set at the new 2024 CPI-adjusted maximum access line rates unless the municipality notifies the Commission of its desired rates no later than April 30, 2024.<sup>3</sup>

In response to that Order, several cities responded to the Commission either by affirming the Commission's default rates or by declining the default rates and choosing different rates less than the default rates.

On October 23, 2001, the Commission issued an order delegating authority to Commission Staff to administratively approve revisions to access line rates.<sup>4</sup> This Notice of Approval is issued in accordance with that authority.

***Ordering Provision***

Attachment A to this Notice of Approval contains the year 2024 city-preferred access line rates incorporating any adjustments requested by the municipalities. These rates are approved and must be implemented prospectively no later than July 1, 2024.
